50/06/23 Report on matters outstanding

Cllr Everard had fitted the new gate closer to the playpark and had repaired one of the older picnic benches. Cllr Pout and Cllr Minucci has commenced the refurbishment of the bus shelter. The farmer had cut the hedges surrounding the triangle. Cllr Pout had invited Burden's to test their grass cutting equipment on the triangle to help keep it under control.
