01/05/2025 -The Government internal system is going to change as to which councils areas are run by which councils. By May 2027 the ghost Councillors will be elected and they will run along side the current Councillors until 2028. Unitary's will be set up for the areas which will put more on Parish Councils to deal with.

District Councillor Whittle suggested that the Council leases the land where the dog park is going to be to the village hall for a peppercorn rent of £1.
